

# **RoHS, REACH CANDIDATE LIST & TSCA LIST**

23.01.2025

Information regarding the RoHS, REACH candidate list and the TSCA restricted substances list.

First, we should like to point out that there are no substances contained in our range of products mentioned in the RoHS directive and REACH candidate list, which are subject to the communication obligation. We also adhere to those threshold values on the TSCA restricted substances list which are relevant to our products.

**RoHS III (2015/863/EU)** is an amendment to the first RoHS directive (Directive 2011/65/EU of 8th June 2011). The directive restricts the use of hazardous substances in electronic products.

The products of Elektro-Isola A/S observe the limit values of 0,1% and 0,01% for the concerned substances mentioned in the RoHS directive.

**The REACH candidate list** is a list of substances, which later may be accepted in the authorisation regulation (Annex XIV), which means that companies using these substances must apply for authorisation to use them. In the candidate list only SVHC substances (Substances of Very High Concern) are entered.

Elektro-Isola A/S is regularly checking whether a substance has been entered in the candidate list and the authorization regulation according to REACH Regulation 1907/2006.

Furthermore, Elektro-Isola A/S is regularly checking that we meet our obligations as far as communication is concerned according to REACH article 33. Article 33 stipulates that each individual supplier of an article containing one or more substances from the candidate list in concentrations of more than 0.1% w/w is to furnish the receiver of the article with information sufficient for the article to be used in a safe manner.

**The TSCA restricted substances list** is a list under Section 6 of the TSCA, where the U.S. Environmental Protection Agency (EPA) lists substances or substance groups the Agency is striving to limit within U.S.

Each individual listing is followed by a file explaining which products under the Industrial Classification System (NAICS) codes are covered by the ban/limitation.

3. As stated above, none of the substances from the lists are part of our technical selection.

Should Elektro-Isola A/S be affected by a substance included in the authorisation or the TSCA list at a future date, an attempt will be made to substitute this substance with an alternative substance which does not require authorisation. If, against expectations, the substance cannot be replaced, authorisation or an exemption will be sought.
